## Miss Murray-Calloway County Fair Pageant

### **Rules & Regulations:**

1. Pageant is open to all naturally born female residents of Kentucky.
2. Contestants must have reached her 16th birthday by October 31st and cannot reach her 22nd birthday by October 31st.
3. A copy of contestant's birth certificate **MUST** be turned in with her entry from **NO EXCEPTIONS**.
4. Contestants cannot be or have previously been married or pregnant.
5. Winner will represent Murray-Calloway County Fair **ONLY** and cannot have any other pageant commitments and compete at the Miss Kentucky County Fair pageant held in January in Louisville, Kentucky.
6. Dressing rooms will be provided. No one will be allowed back stage with contestant. Pageant staff will be available to assist contestants so all family and friends may enjoy the production.
7. No judges' sheets will be given and all Judges' decisions will be final.
8. The contestant will be disqualified from the competition and forfeit all awards, prize money, and sponsorships for any reason deemed appropriate by the pageant director and/or fair board.
9. Grounds for disqualification can be, however are not limited to: false statements/information on registration forms, interaction with judges prior to competition, poor sportsmanship of contestant (or family/friends of contestants), inappropriate conduct, obscene or foul language and any other reason the pageant director and/or fair board may deem appropriate.
10. Miss Murray-Calloway County Fair winner must submit their paperwork to the pageant director no later than 30 days after crowning. If paperwork is not submitted timely the pageant director will automatically assume the winner wishes to forfeit her title and the 1st runner up will be awarded the winner's title. Upon forfeiting of the winner's title all awards, crown, sash, prize money, gifts, and sponsorships must be surrendered to pageant director immediately.
11. Miss Murray-Calloway County Fair is required to attend a minimum of two nights of the fair, attend the Miss Murray State Pageant, participate in the Murray State Homecoming parade and one other local (Murray-Calloway County) parade, attend one local (Murray-Calloway County) event of her choice during her reign, and attend her successors crowning the following year.
12. No entry refunds.
